- **B.** RELEASOR agrees and consents that this Release of Liability will be used by RELEASEE A and, but not limited to its sponsors, staff members, successors and assigns, their respective heirs, affiliates, and any persons, firms or cooperations liable or who might be claimed to be liable, whether or not herein named or not, none of whom admit any liability to the RELEASOR, denying liability from any claims, demands, actions, causes of actions or suits of any kind whatsoever, which have or may hereafter have arising out of or in any way relating to any injuries, physically as well as mentally and also but not limited to damages and/or injuries that may develop in the future, as a result of or in any way relating to the liability;
- **C.** RELEASOR certifies that he/she is physically fit and that there are no health-related reasons or problems which preclude participation in any activity organized by or related to RELEASEE A;
